Terms and Conditions

**Competition Rules**

The following competition is being held and promoted by GMHBA Limited trading as GMHBA ABN 98 004 417 092 of 60-68 Moorabool St, Geelong Victoria 3220 Telephone 1300 446 422 (Promoter).

By participating in the **Brisbane Lions, GMHBA Fan Portal** promotion (Promotion), each entrant unconditionally accepts and agrees to comply with and abide by these Terms and Conditions and the decisions of the Promoter which are final and binding in all respects. The Promoter's failure to enforce any one of these Terms and Conditions will not give rise to any claim or right of action by the entrant or any other person.

Opening and closing dates	The entry period for the Promotion begins at 12:00pm (EST) on Monday May 15th and ends at 12:00pm (EST) Tuesday 23 <sup>rd</sup> June 2026 (Promotion Period).
